Rapport de présentation

Relatif à un projet de délibération approuvant l'opération « Plan d'adressage de la Ville de Mahina », le dossier technique, le plan de financement et autorisant le Maire à signer la convention de financement avec le représentant de l'État

Mesdames, Messieurs les Adjointes au Maire,
Mesdames et Messieurs les Conseillers Municipaux,

La présente délibération vise à solliciter une subvention au titre du FIP pour le Plan d'adressage de la Ville de Mahina.

La Commune de Mahina a connu ces dernières décennies une croissance urbaine et démographique rapide et importante. Le système d'identification des voies est inexistant et les appellations données aux quartiers se transmettent verbalement et évoluent au fil des ans en fonction de l'apparition ou de la disparition de tel magasin ou de telle famille dans ce quartier. Certaines de ces appellations existent en plusieurs exemplaires sur le territoire de la Ville de Mahina.

Il s'ensuit une situation préoccupante pour le fonctionnement des services urbains. Sans système de repérage, comment se retrouver ? Comment guider rapidement ambulances, pompiers et services de sécurité ? Comment envoyer du courrier ou des messages à domicile ? Comment identifier les équipements urbains ? Comment faire fonctionner les services de recouvrements des impôts et des redevances ?

L'adressage permet de commencer par le commencement, de jalonner la Ville de Mahina avec des moyens simples susceptibles d'être mis en place par la Municipalité et de consolider son savoir-faire dans quatre domaines prioritaires : (a) recueillir l'information urbaine et faciliter la mise à jour de documents simplifiés de planification urbaine, (b) programmer les investissements, (c) entretenir les équipements et infrastructures et (d) améliorer la mobilisation des ressources locales.

La commune de Mahina a finalisé la partie « Etudes » de son adressage sur l'ensemble de son territoire. Le travail a consisté en l'identification des voiries ouvertes au public, à la hiérarchisation de ses voies, au recensement des entrées des bâtiments et propriétés avec un descriptif des supports (poteau, numéro existant, boîte aux lettres existantes...) et à la numérotation métrique et séquentielle sur Système d'Information Géographique (SIG).

Aujourd'hui les élus de la commune doivent nommer l'ensemble des voiries, valider le choix et la typologie de la signalétique et lancer la fourniture et pose de l'ensemble de la signalétique. La commune a choisi une numérotation séquentielle et métrique. En effet, la commune est en plein développement et dispose encore de nombreuses friches et terrains à valoriser.

Le projet d'adressage est estimé à 68 515 521 CFP TTC et comprend : la fabrication des plaques, la pose des plaques sur support existant du particulier, fourniture et pose des poteaux pour les plaques sans support, DICT pour chaque fouilles, réalisation des plan de récolement, fabrication des écriteaux, fourniture et pose des poteaux pour panneaux, création de la carte fiver avec l'adressage communal, mailing et/ou publipostage aux entreprises (Guide pédagogique adressage), communication d'information dans les médias, mise à jour du SIG sur la base de données 2015, avant projet détaillé, assistance de passation des contrats des travaux, visa des études d'exécution, direction de l'exécution des contrats des travaux, assistance au Maître d'ouvrage pour les opérations de réception.
